1. Definition

a. Personal data

Information that allows to identify someone

b. User

A person using the Website https://bitcoinasset.io/

c. Data collection

A process carried out by BITCOIN ASSET on User Personal Data

d. Cookies / Third Parties

A collection of information containing track records and activities while browsing the website

2. Personal Data

- **a.** User must be of legal age to be responsible for registering personal data on the Website or any services we provide
- **b.** Protection of User Personal Data is very important to us and applicable legal policies. This policy explains the purpose and how users' Personal Data is collected, processed and maintained by our Website for the maintenance of our Blockchain
- **c.** If you use this BITCOIN ASSET "BTA", we can receive it automatically or via a third parties, such as your name, e-mail address and others via cookies

And every website, have a different policy of service, if you do something on a third parties website, we do not accept responsibility for their policy on processing your personal information.

3. Collected Data

The types of data we collect directly or through third parties, We really respect and maintain the privacy of users and will not collect and process data (Name, Gender, Address, Mobile Number, email, IP etc.) unless:

- a. User give permission
- b. Collected as a result of specific verification conducted by third parties
- c. Automatically collected by cookies or other tracking technologies

4. Methods of Collecting Personal Data on Our Website

We from the Website https://bitcoinasset.io/ collect User Personal Data through:

a. IP address

b. Cookies

When a User visits the Website, any information can be saved automatically on his computer. This process is called a "cookie." We use cookies on some of our pages to store your preferences and record session information

5. Rules for Processing, Access User Data by Employees and Third Parties

- a. Can use a computer and follow the procedures that have been made
- Only (Employees / Third Parties) can access user's Personal Data for processing. (Employees / third parties) are required to comply with the existing regulations for data confidentiality.
- c. (Employees / third parties) are not allowed to Sell, Send or Share User Personal Data to other Parties (which may be used for their own purposes). However, we can provide or disclose User Personal Data to third parties who are responsible for and involved with the processing of User Personal Data on this Website, both Internal and External.

6. Use of Personal Data

Personal Data that has been provided or sent by users can be used as:

- a. User Account Registration
- b. Respond to inquiries and correspondence
- c. Marketing analysis (understanding user needs and improving services to provide relevant information)

- d. Comply with applicable legal or regulatory requirements
- e. Make sure the website is functioning properly

We can also use or process User Personal Data if:

- a. The user has given approval or permission

BITCOIN ASSETS (Employees / Third Parties) can be allowed to save a Personal Data for a long time if the User has given permission for such processing.

When the Personal Data retention period has been expired, User Personal Data will be deleted. Therefore, the rights of the user to access such as deleting, repairing / updating, etc. cannot be accessed again.

If at any time there is a risk for the User, then we from BITCOIN ASSET are not fully responsible.

7. The Rights of Users

We give rights to all Users regarding their Personal Data which will be processed by (Employees / third parties):

a. Withdraw the decision at any time

Users can withdraw the decision they have given to us for processing their Personal Data

b. Object to data processing

Users have the absolute right to object to the processing of their personal data if the processing is carried out on a legal basis other than consent (public interest, in the exercise of official authority granted to Employees / third parties or for legitimate interest purposes carried out by Employees / third parties). The user can object to such processing by providing a basis relating to their particular situation to justify the refusal

c. Access to Personal Data

Users have the right to know that BITCOIN ASSET (Employee / third party) is processing their Personal Data

d. Verification of Personal Data

Users have the right to verify and make changes to the accuracy of their Personal Data

e. Knowing the Status of User Personal Data

f. Make a Complaints

Users can submit Claims in front of data protection authorities.
